## OTHER COMPETITION INFORMATION

1. For 24 Hours 3-on-3 Streetz Basketball Marathon 2007, all games will be conducted in accordance with official rules and regulations of street basketball, unless otherwise stated.
2. Each team must register a minimum of 4 players and a maximum of 5 players.
3. The games will be divided into 4 Categories- Boys 18 & under, Men Open, Women Open and Men Corporate.

5. Late or incomplete entries will not be accepted.
6. No changes can be made to the team list after the closing date.
7. Entry fees must be paid to E.ream Sports by 25<sup>th</sup> July '07. There will be no collection of entry fees & indemnity forms on event day. Entries without payment & indemnity forms will not be accepted. Cheque must be crossed & make payable to "E.ream Sports". ## 3-ON-3 STREETZ BASKETBALL RULES & REGULATION

### PLAYERS

- A maximum of 3 players and a minimum of 2 players are allowed on the court at any one time. A player may only represent one team in the tournament.

### COURT

- Only one basketball Pole will be used and the boundary will be half the regulation court.

### RULES

- The tournament shall be conducted in accordance with the official rules and regulations of street basketball, unless otherwise stated.
- All matches will be played with duration of 7 minutes per half with 1 minute half-time break. The organizer reserves the rights to alter the timing of the games.
- Substitutions can be made upon injury or during interval. Only registered players can play and any fielding of illegal players will result in disqualification. The team captain is the sole spokesperson for his team.
- No injury time will be given, thus substitution must be made immediately.
- The siren will only set timing for the start of the games, half time and end of the games.
- Each player is allocated 4 personal fouls only and to be foul out thereafter. Players who are fouled out will not be substituted.
- All games shall be controlled by one referee only.
- During the match, the decisions of referees are final and will not be subject to appeal. Unofficial challenging of official authority will result in disqualification.
- If the shot is scored, points will be awarded to scoring team while possession changes.
- A field goal is worth 1 point. A goal from behind the take-back area line is worth 2 points. Both feet must be totally behind the line. However, if one team manages to score 21 points, game ends immediately.
- The ball must be taken to the take back area on non-shooting fouls, violations and after a basketball has been scored. Both feet must be totally within the take back area. Any infraction will result in a loss of possession.
- The ball must be passed from the take back area. It cannot be shot or dribbled. Any infraction will result in a loss of possession.
- The ball must be checked on every take back situation. The defensive teams may only hold the ball for 2 seconds while checking.
- Defending players are not permitted in the take back area after checking until the ball has been passed. The offensive teams must pass the balls from the take back area within 5 secs.
- On a steal or defensive rebound, the ball must be taken behind the 3-point line. Both feet must be completely behind the line. Defence is permitted and play may restart with a pass, shot or dribble.
- 1 free throw will be awarded for each foul committed. Possession will be changed after the free throw shot.
- Dunking is not allowed. Hanging on the rings will result in expulsion from the tournament.
- A technical foul results in 2 foul shots and a loss of possession.
- In the event of a draw in a Grand Final, a 3 minute extra time period will be played.

## **RULES ( Continue )**

- In the event of a tie; any 3 players from each team will compete in a shootout from the free throw line, one shot each, alternate shot. Fouled out players will not be eligible for the shootout. Should tie persist, sudden death will be used to determine the winner.
- Continual fouling or misconduct will result in individual expulsion from the game (without replacement), or at the discretion of the Tournament referee, the entire team may be disqualified.

## **SUPPLEMENTARY RULES**

- All teams should be ready at your respective court to start the games promptly.
- No grace period will be given for teams to start the game. Teams have to take the initiative to move onto the court once the previous game ended.
- Teams are also advised to arrive half an hour before the playing time as the games may start earlier than expected.
- Teams shall concede a walkover if they fail to turn up within 30 seconds after the start of each match as indicated by the siren.
- Any team that forfeits a game without reasonable cause shall be deemed to have withdrawn from the tournament and all points scored for or against the said team shall be null and void and will not be taken into consideration when assessing ranking/tie situations.
- Any team that has decided to withdraw shall pay a penalty fee of \$50.00 and will not be entitled to the free goodie bags.
- The Team Manager shall be responsible for the proper control and the good conduct of their players and supporters. If an appeal is made to any one of the above persons by the presiding Tournament Official and is not heeded, the Organizing Committee reserves the right to take disciplinary action against the team. All teams are encouraged to play in the spirit of fair play and sportsmanship.
- Participating teams shall be responsible for their own belongings, first aid and medical coverage. Even though, a 24 hours 1st aider and ambulance are on standby.
- In the event of any question or matter arising out of any point which has not been expressly provided for in any of the rules governing this tournament, the decision of the Organizing Committee will be final.
- The rules and regulations as depicted above are current at the time of printing. The Organising Committee reserves the right to add, delete and/or vary said rules and regulations at any time as it deems fit.

## **OTHERS**

- Each team must be in standardized numbered jerseys.
- All teams shall be responsible for the cleanliness of the venue
- The organizer reserves the right to reduce the number of scheduled games, shorten playing duration or cancelled, due to rain or unforeseen circumstances. There will be no refund in the event that matches are not played as a result of cancellation.
